Problems of this method.

- User is burdened with deciding how to format article titles, journal names, proceeding references.
- Difficult to reuse references in other documents.

Standard Templates

@article An article from a magazine or a journal.

* Required fields: author, title, journal, year.

* Optional fields: volume, number, pages, month, note.

@book A published book

* Required fields: author/editor, title, publisher, year.

* Optional fields: volume/number, series, address, edition, month, note.

@booklet A bound work without a named publisher or sponsor.

* Required fields: title.

* Optional fields: author, howpublished, address, month, year, note.

@conference Equal to inproceedings

* Required fields: author, title, booktitle, year.

* Optional fields: editor, volume/number, series, pages, address, month, organization, publisher, note.

Getting current L^AT_EX document to use your .bib file

- you need to place the following commands:

```
\bibliographystyle{plain}
```

```
\bibliography{sample1,sample2,...,samplen}
```

Note the lack of whitespace between the commas and the next bib file.

- Bibliography styles are files recognized by BibT_EX that tell it how to format the information stored in the .bib file when processed for output. The style file in this instance is plain.bst
- The .bib file should be in the same directory as the L^AT_EX Document. if your .bib file was elsewhere, you need to specify the path as well, e.g `\bibliography{/some/where/sample}`
- In order to get the references actually included, the BibT_EX program has to be run, and after that L^AT_EX has to be run at least twice. In T_EXnicCenter, this will be accomplished by just pressing the Build button a few times.

Bibliography Style

- In L^AT_EX, one can use a number of different bibliography styles. This style defines the layout of the pointers in the body text (e.g. “[1]”), as well as the layout of the reference list.
- Most common are abbr, acm, alpha, apalike, ieeetr, plain, siam and unsrt.
- This is how the L^AT_EX-source might look like:

```
\bibliographystyle{ieeetr}
      % or: plain,unsrt,alpha,abbr,acm,apalike,... ...
\begin{document} ... Reference to a paper in proceedings
\cite{fanty:icassp93}, to an article
\cite{linde:tcom80}, and to a book
\cite{abut:book90}. ...
\bibliography{abbr_long,pubext} % expansion macro's +
      entries from pubext.bib ...
\end{document}
```

Styles Description

- plain.bst** The entries in the bibliography are ordered alphabetically; each is assigned a running number in square brackets as the in-text reference marker, printed where `\cite` commands are issued.
- alpha.bst** Entries ordered alphabetically (same as plain), and markers are an abbreviation of the author's name with year of publication. For instance, a reference to Smith (1987) would appear as [Smi87].

Tips on Bibliography

Including URLs in bibliography

- There is no field for URLs. One possibility is to include Internet addresses in howpublished field of @misc or note field of @techreport, @article, @book:
 - HOWPUBLISHED =
`"\url{http://www.fermentas.com/techinfo/nucleicacids/maplambda.h`
 - **Note** the usage of `\url` command to ensure proper appearance of URLs.
- You need to use `\usepackage{url}`

Cross referencing

- BibT_EX allows referring to other publications via the `crossref` field. In the following example

Tips on Bibliography

```
@INPROCEEDINGS {author:06,

  pages    = {330-331},

  booktitle = {Proceedings of the Xth Conference on XYZ},

Tips on Bibliography

Customizing bibliography appearance

- A bibliography style file (.bst) will tell L^AT_EX how to format each attribute, what order to put them in, what punctuation to use in between particular attributes etc. Unfortunately, creating such a style by hand is not a trivial task. Which is why Makebst (also known as custom-bib) is the tool we need.
- Makebst can be used to automatically generate a .bst file based on your needs. It is very simple, and actually asks you a series of questions about your preferences. Once complete, it will then output the appropriate style file for you to use.

Citation

- Go to the point where you want the citation to appear, and use the following: `\cite{cite_key}`, where the `cite_key` is that of the bibitem you wish to cite.
- When L^AT_EX processes the document, the citation will be cross-referenced with the bibitems and replaced with the appropriate number citation. The advantage here, once again, is that L^AT_EX looks after the numbering for you.

Referring More Specific

- Sometimes you want to refer to a certain page, figure or theorem in a text book. For that you can use the arguments to the `\cite` command:

```
\cite[p.215]{citation01}
```

- The argument, "p. 215", will show up inside the same brackets

Citation

Multiple Citations

- When a sequence of multiple citations are needed, you should use a single `\cite{}` command. The citations are then separated by commas. Here's an example:

```
\cite{citation01,citation02,citation03}
```

No cite

- If you only want a reference to appear in the bibliography, but not where it is referenced in the main text, then the `\nocite{}` command can be used, for example:
 - Lampport showed in 1995 something... `\nocite{lampport95}`.
- `\nocite{*}`, includes all entries from the database, whether they are referenced in the document or not.

Natbib

- Using the standard L_AT_EX bibliography support, you will see that each reference is numbered and each citation corresponds to the numbers. The numeric style of citation is quite common in scientific writing. In other disciplines, the author-year style, e.g., (Roberts, 2003), such as Harvard is preferred.
- `\usepackage{natbib}`
- you need to change the bibliography style file to be used, so edit the appropriate line at the bottom of the file so that it reads: `\bibliographystyle{plainnat}`
